Approval of Equipment List

Tim mentioned that Trumbull Solid Waste has some equipment they are planning on purchasing and wanted to know if they needed ADP approval. Chuck said if they are using a VPN connection which gives them access to New World and connecting to the network they would need ADP approval. Tim said they have their own stand-alone Board so they have a different set of rules they go by and didn't know if there was any legal review from the Auditor side of cutting the purchase order (PO). Chuck said if they are going through our office to cut a PO they would need ADP approvals. Tim said they can talk further about the issue at a later date.

Approval of Woolpert Contract

Chuck stated Woolpert who had been contracted through Frank to do flyovers for the Appraisal office was not properly approved by the ADP Board, did not go out for bid nor, was the contract approved by the Prosecutor's office. Chuck invited Linda Applebaum, the APA for the Auditor's Office, to come to the meeting because she had reviewed the contract. Linda stated the contract

is enforceable and the Auditor's Office would be in breach if they tried to terminate it and then Woolpert could sue. Chuck met with Woolpert representatives regarding contract clean up, but they would not renegotiate. The availability of high resolution images is a part of the issue that Chuck broached with other Counties. Chuck said the State has ownership of the images since it is a State bid the County does not. The County must pay the remaining half of the contract for services that have not yet been provided. We also have two bills for touch up fly-overs that have not been paid. The bills are currently late due to issues with the current contract. The ADP Board has to approve the contract in its current form before the bill can be paid. The Engineer's office was excluded from the current contract, but would like to be included in any future contract discussion.

Approval of Geauga Trumbull Solid Waste Phone System

Allen explained their phone system is similar to the County's phone system. ADP made sure the phones coming through a VPN connection and a PC system will not see each other and link up.

Approval of BOE Election System

Chuck said this has been approved through the Prosecutor's office. Debbie explained this is for a new voter registration process. The present system will go forward until after the upcoming election. Debbie stated part of the ADP request is for a remote ballot marking system mandated by the Secretary of State. The BOE received a grant to help pay for this item. The remote ballot marking system is a screen reader for those people that have vision problems. Debbie said 63 counties in Ohio already have this system and say it's wonderful. Debbie said they already have one contract in place and don't want to breach it so this will be a very slow process of a change over to Accessible ballot marking tool which has to be put in place by September 1, 2018 per a Secretary of State directive and was part of their 2018 budget.

Approval of ADP Equipment Pre-Approval List

Chuck explained this Pre-Approved list cuts out some of the approval office timing. Chuck said there was some consternation about holding up departments for these smaller items and this is a way for ADP to help speed up the process.
