I am pleased to present you with the 2015 Annual Report for the Geauga County Automatic Data Processing Board (ADP Board).

In 2015, the Dept. of Information Technology (DoIT) worked diligently to address ever expanding need for secure online data, mobile access and of course vendor product retirements. The latter includes the continued removal of insecure technology including Microsoft Windows XP and Server 2003 both void of any additional manufacturer support even for security issues. The year also identified several issues including evolving such that the mobile phones of the citizens can effectively access data including high volume access during the 2015 Primary and General Elections.

Our security and operational practices were once again deemed flawless by the Ohio Auditor of State and secure within the bounds of the Criminal Justice Information Systems (CJIS) and other audits as required by the Ohio Attorney General. It is an explicit goal to not only adhere to the security requirements of the Federal and State applicable standards but to also proactively protect the integrity of the county staff's access and the citizens information stored within the ADP environment.

This report highlights the work of the department and is indicative of the team's commitment to technological excellence and direction based on the county's evolving needs. The Department of Information Technology (DoIT) has also taken giant steps in formalizing our commitment to exceptional customer service through the development of new service standards and tools. All employees are being trained to implement these standards and soon we will measure our performance just like a private sector business. This year the network evolved to include Ten Gigabit connectivity at the 470 Center Street complex as well as the Courthouse Annex Data Center.

Through this architecture the county's ADP services continue to over 100% availability on many of their systems servicing the departments and in turn you, the citizens.




# 2015 Service Requests By Department



Service Calls addressed is a true metric as to the ADP philosophy's success. Handling over 22% more issues and 8% more projects we demonstrated pragmatically our operational tactic of "work smarter" with the same headcount as 2014 we provided more support, upgrades, project migrations, new equipment rollout and antiquated equipment retirement.

#### The Infrastructure

The core of the I/T environment is composed of 73 Cisco 12 and L3 Switches in a backbone/campus environment support 46 Virtual Lan (VLANS) that also insure both performance and speed requirements of both high speed disk/file system access (10Gbit). The Wireless Infrastructure supports 3 Wireless LAN Controllers, 49 Lightweight Access Points, 10 Access Points and 12 Meraki Access Points strategically placed in outlying facilities. (Leveraging the cloud based management opportunity)


The network provides for centrally managed communications between Data/Application servers and Voice servers. All servers are based on Microsoft Virtual Server (HyperV) technology.




